Catchment Action Plan Reviews

GLENRAC hosted a CAP 2 information session yesterday, Monday 18th June in Glen Innes for interested landholders to attend.

At this meeting the Northern Rivers CMA presented their new Discussion Paper 3 and opened the new community feedback survey for public comment.

The new discussion paper is on "New Directions for CAP 2". In the paper, find out how your sub catchment rates for community capacity and landscape health.

We have six weeks in which to submit comments on the CAP review process.

The CMA's are interested in what you think, in particular about;

1. How the proposed

new directions for CAP 2 affect you, and

2. What do you think are the major issues affecting community capacity and natural resource health in your area?

How can I provide my feedback to the CMA?

Contact GLENRAC and we can provide you with a hard copy of the Discussion Paper and the Community Feedback Survey.
