BUILDING LOCAL LAND SERVICES

One team

Local Land Services will bring together LHPA, CMA and DPI advisory services. Being a part of the one organisation will make it easier for these teams to work together to achieve even better outcomes for farmers, landowners, key partners, community and industry groups.

Draft regional boundaries

The Local Land Services Stakeholder Reference Panel has proposed a set of regional boundaries for the new organisation. A draft map and some information on the rationale for the proposed boundaries has been placed on the NSW Government Have Your Say website at haveyoursay.nsw.gov.au/locallandservices and is now open for public comment.

Regional boundaries are an important building block for the establishment of the Local Land Services model and it is important that farmers, landowners, our key partners and the community have the opportunity to contribute ideas and feedback before any final decisions are made.

As the boundaries are a critical initial building block for Local Land Services, decisions will need to be made quickly to ensure we can continue to build the new organisation in a timely manner. The Reference Panel has therefore set a short time for comment on the boundaries. Other critical decisions on Local

Land Services will have more time for comment and consideration.

Closing date: Consultation on draft regional boundaries closes Friday 7 December 2012. When forming your opinion on the proposed boundaries, please keep the following principles in mind.

Local Land Services boundaries should:

Contain similar landforms and land-use where possible: Current landscapes are the expression of biophysical form, land use and management and their interactions with land capability. For example, dryland cropping and irrigation occurs predominantly in the cleared landscapes of the NSW central slopes and plains. Efficiency gains can be realised if planning and implementation occurs in areas that contain similar landforms and land-uses.

Recognise community engagement and interaction at a local government scale: People have a clear idea of their local community area, sometimes referred to as 'community of interest'. Many communities readily identify with their local government area. Local Land Services will rely on effective engagement with local governments to help deliver efficient services and better outcomes for their communities.

Support effective service delivery and local decision making: Local Land Services have been created to better connect with customers and

communities in engage decision making at the local level. The boundaries should ensure Local Land Services can be client focused and agile to respond to biosecurity emergencies, while also promoting improved productivity and environmental stewardship of private land. Boundaries should be an appropriate size to deliver effective services.

The Border Rivers - Gwydir Catchment Management Authority is supporting a preliminary study of Brushturkeys in the area surrounding Warialda and Binagra.

If you have seen a Brush-turkey, or have mounds on your property, it would be great to hear from you. If you would like to know more wildlife cameras could be set up on or nearby mounds to determine how many birds could be in the area and how many feral animals are visiting mounds.

The information collected will be used to determine the actual size and distribution of

the Brush-turkey population in the area and what feral animal control could assist their survival.

ENERGY EFFICIENCY MASTER CLASS
